Belarus reinstates mandatory National Energy Efficiency/Energy Labelling (EE/EL) Requirements from January 3<sup>rd</sup>, 2025 for energy using electrical appliances.

In accordance with the Resolution of the Council of Ministers of Belarus dated 26.09.2024 #708 Belarus reinstates from January 3<sup>rd</sup> 2025 the mandatory energy efficiency requirements for certain (4) product categories listed in the Resolution of the Council of Ministers of Belarus dated 21.10.2016 #849, in particular:

#	Clause in 849/2016	Product category for which mandatory BY EE/EL requirements reinstated from January 3 <sup>rd</sup> ,2025
1.	3.1	Cooling household devices: refrigerators, freezers and their combinations
2.	3.2	Electric ovens (including integrated in kitchen stoves) except for portable and not equipped with an adjustable thermoregulator (thermostat); electric hobs (including integrated in kitchen stoves) except for portable
3.	3.5	Washing machines
4.	3.8	Non-directional lamps (incandescent lamps, fluorescent lamps, LED lamps)

From 3<sup>rd</sup> January 2025 the four above mentioned product categories when placed on Belarus market shall be accompanied with Belarus Energy Efficiency Certificate. The Certificate shall be issued by a Belarus accredited Certification Body for Energy Efficiency. BELLIS Testing and Certification is a Belarus accredited Testing Laboratory and Certification Body for Energy Efficiency and issues mandatory Belarus EE Certificates. Availability of Belarus EE Certificate will be checked at the customs and on the market.

For other products categories listed in Resolution 849/2016 (clause 3) but not listed above, the EE/EL requirements from 01.01.2023 remain still voluntary. Customers can apply BELLIS Testing and Certification for Belarus EE Voluntary Certificate for those products (that is cl. 3.3 air-conditioners, cl. 3.4. dish washers, cl. 3.7. external power supplies, cl. 3.9 TV sets and TV monitors, cl. 3.10. household and office equipment). Many well-known brands have continued to receive voluntary Belarus EE Certificates (BELLIS Testing and Certification) in 2023-2024 (advantage on the market + possibility of renewal of mandatory BY EE/EL requirements).

Note: Resolution of the Council of Ministers of Belarus dated 21.10.2016 #849 set forth mandatory national requirements in Belarus to energy efficiency/energy labelling of energy using products (clause 3 and 4). It was temporarily suspended (for products listed in clause 3) from 01.01.2023 with the Resolution of the Council of Ministers of Belarus dated 27.12.2022 No.:916.
